Re: **Distribution of OPTI Products in Russian Federation (the "Territory")**

TO WHOM IT MAY CONCERN:

This letter confirms that in accordance with and subject to the terms of the Distributor Agreement dated April 1, 2020, as the same may be modified from time to time (collectively, the "Agreement"), between Distributor and IDEXX Distribution, Inc. ("IDEXX"), Distributor has been appointed as an authorized distributor in the Territory of products supplied by IDEXX's OPTI Medical Systems division (the "Products"), all as more particularly described in, and subject to the terms of, the Agreement.

Under the Agreement, Distributor by its **IDEXX-approved Third-Party Representative and sub distributor "OOO "INTERMEDICA SERVICE" located at G. KILOMETER THE KIEV HIGHWAY 22TH (P.MOSKOVSKY), DOMOVL. 4, PAGE 5, FLOOR 1 (FIRST), BLOCK E, (BUSINESS PARK "RUMYANTSEVO") MOSCOW, 108811, RUSSIAN FEDERATION**, is authorized to represent the interests of the manufacturer in the circulation of Products in the Russian Federation, on an exclusive basis: (i) to promote, sell and service the Products in the Territory; (ii) to participate in Government tenders in the Territory, including but not limited to and (iii) to obtain on behalf and in the name of IDEXX (or, if required by the laws of the Territory, in the name of Distributor) any and all regulatory approvals, licenses or permits (collectively, the "Registrations") required for the importation and sale of the Products in the Territory. Distributor is required, when requested by IDEXX, to transfer to IDEXX, or any designee of IDEXX, all Registrations and applications for Registrations, to the extent such Registrations may be transferred.

The current term of the Agreement expires on December 31, 2020 thereafter up to two additional 1-year terms, through final expiration December 31, 2023, unless either party, in its sole discretion, gives the other party ninety (90) days' written notice of its intention not to renew. Under certain provisions of the Agreement, either party may terminate the relationship upon written notice for default of the other party.

This confirmation is effective only for orders for Products placed with Distributor for delivery on or before December 31, 2021.
